### **METERED SERVICE**

The charge for service is not subject to cancellation or reduction for seasonal or temporary periods. The base rate charge will be the monthly minimum bill for this class of service. All metered rate service base rate(s) have zero allowance for the water usage.

Base rate charges and water usage blocks are by the meter size factor. Billing for each block is calculated on a per cubic foot amount based on the usage rate charge of that block. Usage rates are shown per 100 cubic feet (1 CCF = 100 Cubic Ft).

Note: Utility Excise Tax (5.029%) shall be in addition to the rates in this tariff. Please see reverse for examples on how to calculate charges.

Please note, the above rates are effective May 1, 2019 through October 31, 2019. On November  $1^{st}$ , 2019, the base rate for the meter size 5/8 inch will decrease to \$46.00 and will be reflected on your December  $9^{th}$ , 2019 billing statement.

# READY TO SERVE (RTS)

Applicable to undeveloped properties. Monthly fee is \$46.00 plus Utility Excise Tax (5.029%).

#### **CALCULATING MONTHLY CHARGES**

The following examples illustrate how your monthly charges are calculated. Please note, the majority of households have a 5/8" meter. Less than 3% of our customer base have a meter that is larger.

1. The Smiths have a 5/8" meter. There are two people in their household, and they had consumption of 650 cubic feet in the prior month. Based on the tariff all their usage falls under Block 1. Usage is \$4.05 for each 100 cubic feet falling under Block 1.

2. The Johnsons have a 5/8" meter. There are 5 people in their household. They had consumption of 1400 cubic feet in the prior month. Based on the tariff their usage falls under Block 1 and Block 2. Usage is \$4.05 for each 100 cubic feet falling under Block 1, and \$5.30 for each 100 cubic feet falling under Block 2.

3. The Johnsons own the parcel adjacent to their home. They have a flower farm, which has a 1½ inch meter they use to irrigate. It is the summer and they used 4200 cubic feet in the month of July. Based on the tariff their usage falls under Block 1, and Block 2. Usage is \$4.05 for each 100 cubic feet falling under Block 1, and \$5.30 for each 100 cubic feet falling under Block 2.
